## Notice on HSBC Amanah Standardised Base Rate

Effective from 01 August 2022, HSBC Amanah Malaysia Berhad uses Standardised Base Rate (SBR) as a reference rate for the pricing of all new applications for home financing.

The new SBR is at 2.50%p.a., effective from 19 September 2022. It is the same as the new OPR rate broadcasted by Bank Negara Malaysia (BNM) on 08 September 2022.

## 1. What is the Standardised Base Rate (SBR)

The Standardised Base Rate is and will be used as the common reference rate for all financial institutions for new retail floating-rate financing facilities. The SBR is equivalent to benchmark rate. The benchmark rate shall be set as the prevailing Overnight Policy Rate (OPR) as set out in the Monetary Policy Statement of the Monetary Policy Committee of BNM. In the event of a change in the benchmark rate, Financial Service Providers (FSPs) are to adjust the SBR by the same quantum. Other components of financing facility pricing will continue to be reflected in the spread.

## 2. What are the objectives & benefits of the SBR?

This revised Reference Rate Framework (RRF) outlines an industry-wide, standardised benchmark rate to be used by all FSPs to ensure that the requirements remain relevant and fit-for-purpose to:

- facilitate effective transmission of monetary policy decisions;
- promote a transparent reference rate that enables meaningful comparison of financing products across FSPs to allow consumers to make informed decisions; and
- reinforce sound and efficient practices in the pricing of floating-rate retail financing facilities by FSPs.
