The Terms & Conditions for <u>HSBC Amanah Premier World MasterCard Credit Card-i</u> has been updated and reflected as follows: -

- Original Clause 15(d) has been removed, added new Clauses 15 (g) & (h)
- Original Clause 17(b) has been removed, added new Clause 17 (e)
- Clauses related to Boingo have been removed since the benefits will be demised effective 31st December 2021
- Clauses 72 to 77 have been added to define Complimentary Global Data Roaming by Flexiroam
- Clauses 78 to 85 have been added to define Complimentary Digital Health Services by Allianz

Details of amendments made to each sections are detailed below. Amendments of the sentences are as shown in strikethrough, for deletion, and highlighted, for addition.

The updated Terms and Conditions will be effective 3 January 2022.
