**Discontinuation of HSBC Amanah Perks@Work Programme for new customers and Amended Terms & Conditions for HSBC Amanah Perks@Work Programme**

Please be informed that the HSBC Amanah Perks@Work Programme will no longer be offered to new customers effective 1 February 2026.

We hereby give notice that this Notice will supersede the earlier Notice on Amended Terms & Conditions for HSBC Amanah Perks@Work Programme Terms dated 7 January 2026 and there will be changes to the Programme Offers for HSBC Bank Perks@Work Programme:

- (i) Effective **1 February 2026**:
  - a. HSBC Amanah Credit Card-i annual fee waiver up to 3 years will be discontinued for any new principal HSBC Amanah Credit Card-i approved on or after 1 February 2026.
  - b. Fee waiver for all successful cash withdrawals performed via MEPS' Shared ATM Network will be discontinued for new customers.
- (ii) Effective **1 April 2026**, fee waiver for all successful cash withdrawals performed via MEPS' Shared ATM Network will be discontinued for existing customers.

Following the changes above, HSBC Amanah Perks@Work Programme Terms and Conditions will be revised with effect from 1 February 2026.

Below are the amendments made to the HSBC Amanah Perks@Work Programme Terms and Conditions:

HSBC Amanah credit card-i annual fee waiver up to 3 years offered under this Programme will be discontinued for new principal HSBC Amanah credit card-i applied from 1 February 2026 onwards. 7. Fee waiver for all successful cash withdrawals performed via MEPS' Shared ATM Network will be discontinued for new customers effective 1 February 2026, and for existing customers effective 1 April 2026.
